Summer Camps Made a Difference

This year 95 children participated in summer camps provided by the Stevens Center. 26 participants had a diagnosed disability. All camps were open to every person in the community, based on age. This reflects the Stevens Center's philosophy that people of all abilities should be included in the community.

Every camp gave individuals with a disability opportunity to be included in a camp with their peers that do not have a disability. In a couple of cases this meant siblings could be in the same camp—the youth with a disability.

She noted, "At work I am given the plan for a person that lives here, for me to implement. As part of my internship, I actually get to develop my own plan of instruction, and then implement it.

"And, generally," Kelsey continued, "group homes have quite a few restrictions that people living there have to abide by. At the Stevens Center's Connections program, people are given a lot of freedom to learn and grow. I am interested in being able to compare the two different ways of doing things."

Kelsey's long-term goal is to stay in a field related to people with disabilities, perhaps as a vocational counselor. Her experience here should be invaluable.

Javier is a Lee County high school student that volunteered weekly during the summer. His youthful demeanor and love of basketball was a nice addition to the summer program. His consistency was truly appreciated.


